# U.S. Export and U.S. Import Freight Collect Value-Added Services

The information below applies to all levels of UPS international service except UPS SonicAir®, unless otherwise noted.

## Automatic Daily Pickup

A UPS driver will stop at your location each day, Monday through Friday, to pick up all your Ground, Air and International packages. You will also receive Daily Rates, which are the lowest published rates available to UPS customers. Call 1-800-PICK-UPS® for details.

## Billing Options

The Billing Options charges per shipment are:

- \$15.00 Bill Duty/Tax and Shipping Charges to Shipper (Free Domicile)
- \$15.00 Third Party Free Domicile (Third Party pays Duty/Tax and Shipping Charges)
- \$15.00 Delivered Duty Paid, V.A.T. Unpaid

## Certificate of Origin

Can be prepared by UPS on behalf of the shipper for goods manufactured and originating within the United States. The fee is \$10.00 per shipment.

## Currency Conversion Rate Fee

Charges to a payer's account in a foreign currency will be converted to the payer's currency using a weekly exchange rate secured through Major Money Center

Banks. The fee is .75 percent of the currency amount converted.

## Declared Value for Carriage

A shipment is automatically protected against loss or damage up to \$100.00. Additional protection up to \$50,000.00 per package is available upon request. Refer to the "Terms and Conditions" for more information. Declared Value charges are listed below:

## Non-Resident Importer (NRI)

**Applicable When Shipping to Canada.** If you use the Bill Duty, Tax and Shipping Charges to Shipper (Free Domicile billing option) frequently, you should open an NRI account.

A Non-Resident Importer is a shipper in the United States who acts as the

importer of record to the Canadian government. The shipper files the Power of Attorney (clearance authorization) with UPS for clearance of goods in Canada and is responsible for the payment of all Canadian duties, taxes and brokerage fees. The customs clearance process is transparent to the consignee: The consignee is not involved. Goods are delivered after clearance. The shipper undertakes all importing responsibilities as required by Canadian law and must maintain records on all importation into Canada for a period of time prescribed by the Canadian government (for United States NRI account holders, that period is six years).

The NRI option can be utilized on air or ground shipments. Shippers should mark the "Prepaid" billing option on the waybill, record their six-digit NRI shipper number in the "Shipper's UPS Account No." section of the waybill and record their NRI brokerage account number in the "Special Instructions" section of the waybill. Customers who would like to set up an NRI account must contact their UPS representative.

## U.S. Export and U.S. Import Freight Collect Value-Added Services (continued)

### Saturday Delivery

Saturday delivery is available for UPS Worldwide Express Plus<sup>SM</sup> and UPS Worldwide Express<sup>SM</sup>. Refer to [ups.com](http://ups.com) or call 1-800-782-7892 for delivery areas. Each Express Envelope or package must bear a Saturday Delivery routing label. A \$12.50 fee for each shipment is billed to the payer of the transportation charges.

### Shipper's Export Declaration (S.E.D.)

We can prepare and file an S.E.D. on your behalf when all data required is provided and we obtain proper Power of Attorney. The charge per shipment is \$10.00.

### UPS Delivery Confirmation, Signature Required and Adult Signature Required (International, including Puerto Rico)

UPS Delivery Confirmation is included with each of these services; Delivery Confirmation is not available separately. The fee per package for each of these services is:

- Signature Required - \$2.25 per package
- Adult Signature Required - \$3.25 per package

Available by using UPS WorldShip<sup>TM</sup> or a UPS Ready<sup>TM</sup> solution meeting the most current specifications set forth in the *UPS Guide to Labeling*. The shipper selects "Adult Signature Required"

under "Delivery Confirmation," and a smart label is printed with all necessary information included. The printed delivery confirmations are mailed. See the "Terms and Conditions" for details.

### UPS Exchange Collect<sup>SM</sup>

Our alternative to an international C.O.D., UPS Exchange Collect offers a fast, simple payment alternative for international trade. This contract-only international service streamlines payment for goods with this process:

1. Importer and exporter agree to purchase and sale terms and specify UPS Exchange Collect for financial settlement.
2. The exporter ships the goods by UPS. UPS notifies the importer that a shipment is in transit and payment must be made before delivery. The notification includes UPS bank account and routing instructions.
3. The importer instructs their bank to wire transfer payment to the UPS bank account. UPS will not accept cash, checks, credit cards, PayPal or Western Union money/wire transfers.
4. After UPS receives payment, the shipment is delivered to the importer.
5. Upon verification of delivery, UPS remits funds to the exporter.

### UPS On-Call Pickup<sup>SM</sup>

### UPS World Ease<sup>SM</sup>

A contract service for companies with shipments to multiple consignees in a single country on the same day. This service also provides a solution for shipments destined to multiple consignees within the European Union.

Through an automated shipment preparation process, summary documentation is prepared and transmitted with your shipments to UPS, enabling a single customs-clearance procedure covering all shipments in the consolidation. This guaranteed service is a feature of UPS Worldwide Express NA1<sup>SM</sup>, UPS Worldwide Express, UPS Worldwide Expedited<sup>SM</sup> and UPS Standard To Canada.

As multiple shipments will travel together until customs clearance, transit times may vary from traditional single-shipment transit times. Call 1-800-782-7892 for more information.

# U.S. Export and U.S. Import Freight Collect Other Charges

The following information applies to all levels of UPS international service except UPS SonicAir®, unless otherwise indicated.

## Address Correction

If UPS is unable to deliver any package as addressed by the shipper or if the package has an incorrect or incomplete address, UPS will determine and make reasonable efforts to secure the correct or complete address. An address validated by UPS may be incorrect or incomplete for purposes of completing delivery, and may be corrected by UPS. If the correct or complete address is secured, UPS will attempt delivery, the shipper will be provided with the correct address, and an Address Correction charge will be assessed:

- \$10.00 for UPS Worldwide Express Plus<sup>SM</sup>, UPS Worldwide Express NA1<sup>SM</sup>, UPS Worldwide Express<sup>SM</sup>, UPS Worldwide Expedited<sup>SM</sup> and UPS Standard To Canada.

## Disbursement Fee

Customers are responsible for payment of duties and taxes. A fee of two percent (minimum of \$5.00) of the amount paid or processed by UPS on behalf of the customer will be charged.

## Excessive Tracking, Tracing and Refund Requests

The shipper may be assessed a \$3.00 charge per request for excessive tracking, tracing and refund requests. See the "Terms and Conditions" for details.

## Extended Area Surcharge

An Extended Area Surcharge applies to UPS Worldwide Express Plus,

UPS Worldwide Express NA1, UPS Worldwide Express and UPS Worldwide Expedited shipments for some international origins and destinations. Visit [ups.com](http://ups.com)® or call 1-800-782-7892 to determine if a particular origin or destination is classified as an Extended Area. The fee is \$20.00 per shipment or \$0.20 per pound, whichever is greater.

## Freight Collect Refusal – International

This charge applies when the Bill Receiver or Bill Third Party option has been selected and the bill-to party refuses to pay the shipping charges. A fee of \$10.00 per shipment will be charged to the shipper, in addition to the shipping charges and other amounts payable, when non-payment occurs.

## International Dangerous Goods

International Dangerous Goods (IDG) packages requiring Shippers' Declarations, as defined under the International Civil Aviation Organisation (ICAO) and published in the International Air Transport Association (IATA) Dangerous Goods Regulations, are accepted for transportation only as a contractual service. The additional charge for each such package is \$40.00. (Excepted Quantities require a contract for IDG service, but are not subject to the additional IDG charge.) UPS accepts International Dangerous Goods only for transportation within and between defined international service areas. For additional information, call the

## Missing/Invalid Account Number or Refusal Fee

An account number is invalid if it is not the correct account number for the bill-to party, or if it is the account number for a consignee or third party who fails to pay the shipping charges:

- A \$10.00 charge per shipment will be assessed for international shipments with a missing or invalid account number. Additionally, if the consignee or third party fails to pay the shipping charges, the original shipper will be billed a refusal fee plus the shipping charges.

## Over Maximum Limits

Packages with an actual weight of more than 150 pounds, or that exceed 108 inches in length, or exceed a total of 165 inches in length and girth [(2 x width) + (2 x height)] combined, as measured to determine their billable weight, are not accepted for transportation. If found in the UPS system, they are subject to one of the following additional charges:

- Over Maximum Weight: \$50.00
- Over Maximum Length: \$50.00
- Over Maximum Size: \$50.00

# U.S. Export Customs Brokerage Services

## CUSTOMS CLEARANCE FOR EXPORT SHIPMENTS

### **For UPS Worldwide Express Plus<sup>SM</sup>, UPS Worldwide Express<sup>SM</sup> and UPS Worldwide Expedited<sup>SM</sup>**

Rates include routine in-house customs clearance by UPS Supply Chain Solutions<sup>SM</sup>. Additional charges will apply if customs clearance is performed by customs brokerage offices other than those designated by UPS for clearing the services listed above.

Customs clearance for the services listed above is provided by the UPS Supply Chain Solutions customs brokerage offices designated by UPS for

handling small package customs clearance. Other UPS Supply Chain Solutions customs brokerage offices charge fees for clearance of small packages and freight.

### **For UPS Standard To Canada**

Charges for customs clearance are not included in the rate. We will provide customs brokerage services unless otherwise specified by the importer. Customs brokerage charges, duties and taxes will be billed to the importer, unless otherwise indicated by the shipper.
