## **Service Description**

#### **UPS® WORLDWIDE ECONOMY**

UPS® Worldwide Economy Service is a low-cost e-commerce solution for non-urgent cross border shipments originating from selected countries/territories in the Asia Pacific Region to selected destination countries/territories with final delivery through the Worldwide Economy network. This is an end-to-end service with UPS pickup and last mile delivery by a network of trusted UPS partners.

#### **Pickup**

Customers have the option to tender loose shipments to UPS for pickup or drop off shipments to the export site.

#### **Delivery**

Worldwide Economy Delivered Duty Paid (DDP) shipments will be tendered to trusted delivery providers within the country of destination for delivery to the consignee address.

#### **Service Guidelines**

#### UPS® WORLDWIDE ECONOMY

The time and date of delivery are not guaranteed.

UPS® Worldwide Economy rates do not include duties or taxes. Rates shown within this guide are applicable to the international transportation move starting from UPS pickup to the end consignee.

#### **DDP (Delivery Duties Paid) Service:**

UPS® Worldwide Economy packages shipped DDP will be delivered through the UPS® Worldwide Economy network, including contracted service providers. Duties, taxes, and customs clearance fees applicable to such packages must be paid by the shipper, in addition to the rates and other charges applicable to UPS Worldwide Economy Service.

- A declared value liability of up to the local equivalent of USD 100.
- Time-in-transit is an average of 5-8 business days from the Worldwide Economy export site to the end recipient.
- Package shall not exceed USD 800 (or local currency equivalent).
- All packages are subject to the dimensional weight formula of (L x W x H) / 5,000.
- Package size and weight limits:
  - o Length plus girth [(2 x width) + (2 x height)] maximum 330 cm
  - o Length (longest side) maximum 122 cm
  - Weight maximum 30 kg

### **High Value Customs Clearance Fees**

The High Value Customs Clearance Fee will be applied to a package if the package value exceeds the High Value Customs Clearance Fee Threshold in the associated currency listed in the table above. Actual duty and tax rates are based on commodity and are not reflected in any of the UPS Economy transportation rates or fees above.

When using the Landed Cost Calculator, a fee of 10% of the total duties and taxes calculated will be charged. This charge will be included on the customer's invoice.

Package value, which determines whether the High Value Customs Clearance Fee is assessed per the above description, is calculated in these countries based on the value of goods within the package, plus freight and insurance costs of the package.
