

# **UPS® Demand Surcharge**

## August 23, 2024 Update

UPS Demand Surcharge<sup>1</sup> was previously introduced as a response to increased demand for air freight capacity and increased costs to maintain service, resulting from prevailing market conditions.

### **UPS Demand Surcharge**

Please be informed that effective September 15, 2024, and until further notice, UPS Demand Surcharge will be suspended for all Asia Pacific<sup>2</sup> exports and imports. See tables below for more information on the applicable Demand Surcharges that will still apply on selected lanes until September 14, 2024.

Demand Surcharges are subject to change and high demand periods may be extended or otherwise changed. Shippers should continue to check ups.com/rates/jp for updates prior to tendering shipments.

Those billed on a Freight Collect and Third Party basis will be charged in the currency where payors are located. Charges to a Third Party payor's account in a foreign currency will be converted to the payor's currency using a weekly exchange rate secured through Major Money Centre Banks, plus an exchange fee equal to 0.75% of the amount converted.

Please note that Demand Surcharge is only applicable on international shipments, and applies in addition to existing rates, charges, fees and surcharges including UPS Fuel Surcharge.

The following Demand Surcharges will be applied in local currency as a rate per kilogram based upon the billable weight of the shipment, at increments of 0.5kg.
