**UPS Post Sales Ground Fuel Surcharge**

UPS Post Sales Ground uses an index-based ground fuel surcharge that is adjusted monthly. The surcharge is based on the *U.S. Retail Motor Gasoline Prices, Regular Grade* as reported by the U.S. Department of Energy for the month that is one month prior to the adjustment. Changes to the ground fuel surcharge are effective October 7, 2024, the surcharge will be 20.25% based on the September *U.S. Retail Motor Gasoline Prices, Regular Grade* price of \$3.214 per gallon.
